E. Short Project Summary

FTA (Free Trade Agreement) provides Vietnamese businesses with many opportunities: foreign market expansion; attracting direct investment; promoting trading of small and medium enterprises; and others. TPP is one of those FTAs which requires strong environmental commitments such as CSR implementation and compliance with legal requirements on environmental protection. While the implementation of environmental CSR is not only an opportunity for Vietnamese enterprises to boost their reputation and credibility but it also helps direct them towards sustainable development that takes into account people-profit-planet, in accordance with Vietnam's National Green Growth Strategy 2011 - 2020. However, there are certain challenges and barriers to SMEs in implementing CSR and legal environmental requirements. The main issues are: a lack of understanding of rather complex legal environmental requirements in Vietnam and in the world; a lack of awareness and understanding of CSR; and weak compliance capacity. This project proposal is developed to address the above issues, promot active participation of SMEs in TPP through 3 objectives: Obj. 1: To understand deeply about the TPP framework through desk review focusing on CSR, TPP, and legislation on environmental protection in Vietnam; Obj. 2: To develop a training program for small and medium-sized enterprises to meet environmental regulations and CSR in preparation for TPP. Obj. 3: To carry out pilot training of 29 enterprises in Khac Niem, Bac Ninh. The project will be supported by the Environmental Protection Agency of Bac Ninh province who currently manages the Khac Niem industrial zone. The training program, if funded and successful, will be expanded in the national scale in the following 2-3 years.

To develop and organize a training program for small and medium-sized enterprises to enhance capacity in compliance with environmental regulations and implementing CSR to active engaging in TPP.

The challenges of SMEs are policy, finance, technology platform, access to information and awareness in compliance with environmental law. In Vietnam, environmental training only provides up-to-date legal document, it does not provide skills of environmental management for the enterprises.
Number 2: Training program for SME on legal requirements and CSRs to meet with TPP	Output 2 delivered: - A training needs survey was held with 9 enterprises in Khac Niem industrial zone. Their business sectors were very different include electronics, rubber, furniture, mechanics. The enterprise size varied from micro to small to medium. The survey results show that all these SMEs

designed, and ready for trial in Khac Niem Industrial zone had problems in implementing and complying with current environmental laws in Vietnam, such as environmental management in enterprises, waste control measures and minimizing the use of raw materials and energy. On top of that, none of the SMEs had a professional environmental management plan and commitment statement to ensuring compliance with the law in an active manner.

- A SMEs training program for environmental management and compliance as part of CSR program was developed to provide Khac Niem SMEs the basic knowledge to understand through requirement bay law and skills to develop an environmental management plan for each of them, through consultation with experts and research the training programs in Vietnam and in the world, the training program for Khac Niem's SMEs was designed with a comprehensive yet practical content to meet the needs of those enterprises. The other criterias of training (time, method of training) were considered based on the recommendations of experts and those enterprises.
- Training content focused on:
 - + Providing information on environmental regulatory system related to SMEs
 - + The current status of environmental law enforcement of SMEs in Vietnam
 - + Legal and financial risks faced by SMEs in environmental management, common violations of SMEs in environmental management.
 - + Updating the new environmental legislations and requirements.
 - + Introducing best practices in environmental management and corporate social responsibility at SMEs in Vietnam
 - + Guiding the enterprise to develop an environmental management plan in accordance with the law

- Contact trainees: Together with Khac Niem Ward People's Committee and Bac Ninh Department of Environmental Protection, more than 70 SMEs in Khac Niem area have been contacted and sent invitations to participate in the training organized by CECR.
- Recruitment the lecturers: The best experts in the areas of environmental law dissemination and environmental management in enterprises, environmental inspections in enterprises from agencies under MONRE and Bac Ninh provincial Department of Environmental Protection has been invited by CECR as lecturers for the lecture class to be discussed numerous times to meet the program requirements.

The variance in planned and actual expenditure in Output 2 is greater than 5% because of the changing total time to develop the training program. According to the initial plan, the training program will be developed after interview with SMEs in Khac Niem. However, due to the Lunar New Year in Vietnam and advices from the Head of the Department of Natural Resource and Environment of Bac Ninh province and the People Committee of Khac Niem Ward, we decided to delay the field interview and work on developing the training program earlier than planned (December 2016 instead of January 2017). This led to extra days spent on reviewing, consulting and adjusting the training program to fit with SMEs need after the field interview.

- Evaluation form filled by participants show that there are strong commitments to prepare environmental management plan.
- In the workshop on April 28th, organizations such as the Institute of Small and Medium Enterprises, V-Green Environmental Consultancy Company expressed their desire to cooperate with CECR to organize the next training course for small and medium enterprises in Vietnam.

What were the three main lessons identified that could be applicable to running this type of project again?


- At the workshop, main recommendation is that there is a need of development of training course for microenterprises (less than 10 employees) and programs for small and medium enterprises separately. Different businesses have different training needs.
 - Teaching methods: field trips to enterprises have good environmental management should be supplemented to the training program so that the trainees can directly exchange and learn experiences.



B. Training program in Khac Niem




